

Hallyu Olympiad K-pop Dance Cover Competition

Terms & Conditions

Additional T&Cs with effect from 22 July to 15 August 2021.

Participants hereby acknowledge and agree to the following:

1. There will be no change to the deadline of the competition as of now.
2. With effect from 22 July 2021, all groups are to reduce group members from 4 pax to 2 pax according to prevailing Government measures.
3. Participants are allowed to submit videos that are filmed before 22 July 2021.
4. Participants are to ensure that videos submitted are in line with prevailing measures at time of filming.
5. Submissions that do not comply with prevailing Government regulations will be disqualified.

Terms & Conditions:

1. KTO Singapore ["The Organizer"], in its sole discretion, reserves the right to modify these Rules & Regulations without any prior notice, if required for the smooth running of the Competition. The Organizer's decisions are final and no correspondence thereon will be entertained. By participating in this Competition, participants agree to be bound by these Terms and Conditions, and the decisions of the Organizer.
2. Each Participant consents to the collection, usage and/or disclosure of each Participant's personal information by the Organization to the Organization's employees and event partners, as may be required for the administration of the Competition.
3. Each Participant consents to the usage of any photographs and videos taken by the Organizers (which may capture said Participant) in any manner as the Organizers deem fit, including but not limited to use for publicity purposes or such other use in future, without the need for further approval or consent from the Participant.
4. Each Participant warrants that he/she is physically fit to participate in the Competition and that the Organizers shall not be liable for any loss/injuries/damages suffered by the Participants as a result of his/her participation in the Competition.
5. Participants shall be responsible for their use of any musical works as part of their video submission. The Organisers shall not be responsible for any claims of infringement of intellectual property rights by third parties.

The Hallyu Olympiad K-pop Dance Cover Competition consists of 2 rounds:

- PRELIMINARY ROUND: Online submission of a cover of any K-pop Dance
- FINAL ROUND: Finalists will have to prepare a cover of a K-pop Dance, choice of song will be from 4 most recent songs (2 girl group & 2 boy group).
- Mode of the Final Round will either be at an Offline venue or via Online submission[^].

Preliminary Round

- Online submission period is from **15th July 2021 - 15th August 2021, 2359hrs.**
- Open to only Singaporeans or Singapore Permanent Residents, aged 18 and above.
- Participants can join as a solo or as a group of maximum 4 members[^]. [[^]subject to change in accordance with prevailing Government regulations and Safe Management Measures (SMM)]
- Choice of music: any K-pop song (*Korean versions only*).
- Groups are to maintain the same performers for all stages of the competition.
- Reduction/ change in performers during the contest due to unforeseen circumstances may be permitted and subjected to approval by the Organizers. Reduction of members may be requested for the Global Hallyu Olympiad in Korea*.
- After the application period, a panel of judges and KTO Singapore will be selecting the TOP 5 groups to qualify for the FINAL ROUND.
- Finalists will be announced on 23 August 2021, on KTO Singapore's social media channels and contacted by KTO Singapore via email.

Final Round

- Final round will take place during mid - end September 2021.
- Finalists will be given a choice of 4 songs to choose from (*2 girl groups & 2 boy groups, list of songs to be announced on 23 August 2021*).
- Mode of the Final Round will either be at an Offline venue or via Online submission.
 - Offline: Finalists are to compete at a venue in front of a panel of judges
 - Online: Finalists are to proceed with Online submission*Mode & schedule will be announced at a later date[^]. ([^]subject to change in accordance with prevailing Government regulations and SMM)*
- Each individual/group will have to showcase a different song choice from the one submitted during the PRELIMINARY ROUND.
- Group members must remain the same as from the Preliminary Round.

- Final winners will be announced on KTO Singapore’s social media channels and contacted by KTO Singapore via email.

Online Submission

- Upload your video on your own YouTube account (make sure to set it to public) and include a caption of how you fell in love with K-pop.
- Appoint one representative of the group to fill out the registration form on our website www.hallyuolympiad.com
- Any submissions after the stipulated deadline will not be considered and immediately disqualified.

Video Requirements

- Video must not exceed 5 minutes.
- Video resolution should be at least 720p.
- Participants are to ensure that they comply with prevailing Government regulations and SMM, including but not limited to maintaining a safe distance of 1m between participants during filming.

Judging Criteria

40% - Choreography and Technique

30% - Overall Concept

20% - Execution and Presentation

10% - Surprise Element

Panel of Judges

- The judging panel will consist of KTO Singapore, a Representative from the Embassy of the Republic of Korea to the Republic of Singapore and Professional judge(s).
- All decisions made by the judges are final and no appeal will be entertained.

- First place winners will win a Samsung Galaxy S21 and an opportunity to participate in the KTO Global K-pop Dance Cover Competition in Korea in November 2021*.
- *The trip to Korea is dependent on the commencement of the Global Hallyu Olympiad, which will only commence when travel between Singapore and Korea is permitted. In the event where overseas travel is not permissible at the time of the travel date, the winner shall keep the Samsung Galaxy S21 as the Grand Prize. The trip to Korea is non-transferable and non-exchangeable.
- The Prizes can only be claimed by the winner(s) in person^ (^subject to SMM measures) within the collection period at Korea Plaza, 3 Church Street, #01-02 Samsung Hub, Singapore 049483 from Monday to Friday, 9AM – 6PM.
- In the event that one representative of the winning group comes down to collect the prize, The Organizer will not be liable for anything that happens after prizes are collected.
- The winner must produce their original IC / passport with a legible IC / passport number in order to claim the prize. The winner may also be required to produce additional original proof of identity at the discretion of the Organiser.
- All personal particulars furnished are meant for identification purposes and will not be sold or given to any third parties.
- In the event that the Organiser cannot for any reason obtain the Winner's acknowledgement within the time frame stated after the announcement of winners, the Organiser reserves the right to withdraw any prizes and select a replacement Winner at Organiser's sole discretion.
